

TERMS AND CONDITIONS RANDSTAD GOLD VJ AWARD

- The closing date for entries for the Randstad Gold VJ Award is midnight on Tuesday, 31st of August
- Submission format is 1920 x 1080 25fps interlaced Prores 422 Quicktime or Uncompressed Quicktime
- Submissions have to be on a black background and need to be optimised for the Musion screen and should be no longer than 3min 20seconds.

1. This competition is open to artists and animators aged 18 years or over.

2. All information detailing how to enter this competition forms part of these terms and conditions. A condition of entry is that all rules are accepted as final and that the competitor agrees to abide by these rules. The decision of the jury is final and no correspondence will be entered into. Submission of work will be taken to mean acceptance of the terms and conditions.

3. Entries should be submitted by post on harddrive, DVD or USB stick to Musion Systems LTD. 35 Portland Place W1B 1QF or via email digital delivery to oliver@musion.co.uk Entries must be labelled with the entrant's name and video files must be 1920 x 1080 in quicktime format 25fps - ideally uncompressed or prores422 codec. Entrants should include their own name, address and telephone number. We regret that we are unable to accept late entries.

4. All entries must be received by the advertised closing time and date.

5. All videos submitted must be the work of the individual submitting team and authorship and copyrights of source footage must be with the entrants. It is the responsibility of each entrant to ensure that videos submitted have been taken with the permission of the subject and do not infringe the copyright of any third party or any laws. Entrants must warrant that the videos they are submitting is their own work and that they own the copyright for it.

6. Copyright in all the videos submitted for this competition remains with the respective entrants. However, each entrant grants a worldwide, irrevocable, perpetual licence to Musion Systems to feature any still images of submitted footage in any of their publications, their websites and/or in any promotional material connected to this competition - for non-commercial and reasonable marketing use only. The shortlisted submissions may be shown within the protected Randstad Intranet, in print and on leaflets. The winner may be published on the Randstad and Musion Systems website.
